Method of Payment

The Ottawa Flying Club requires that all purchases, including flight training, be paid in full in the following manner:

1. At the end of each session or at the end of the day if your flying activity completes during normal business hours; or
2. In advance if your flying activity will complete after normal business hours.

The Ottawa Flying Club will not extend credit terms to Club Members. To ensure your membership privileges are maintained, you are encouraged to keep a positive account balance by making lump sum payments to your account.

In case the funds on account are insufficient to cover flights and to facilitate payment, the Club requires each Student, Flying or Life Member to provide valid credit card information. This information will be held securely and used to preauthorize payments and pay any outstanding balances on your account. If credit card information is not provided, all payments must be made in advance.
